Medical Dream of Generations

The medical dream of generations was to build a medical body and medical research based development run by the citizen of Bahrain.

The dream started seventy years ago with Dr. RHB Snow (former director of medical services, 1940-1970) who encouraged the training of Bahraini doctors, gave them a good status (class 'A' special, housing and good salary); also he encouraged the training of Bahraini nurses and inaugurated a nurses' training school on the island. Dr. Ali Fakhroo (former minister of health, 1971-1982) established various medical specialties, established scholarship and medical training abroad, college of health sciences, regional health centers and finally Arabian Gulf University with a medical college, which serves the GCC. Mr. Jawad Al Arrayed (former minister of health, 1982-1995) had increased the training and scholarship budget; during his term, the ground was broken for a major expansion of the Salmaniya Medical Complex (300 beds) in 1992, it was completed and opened by Dr. Faisal Al Mosawi in 1996, Al Arrayed initiated the computerization project of SMC departments and finally he supervised the conversion of SMC from service hospital to a teaching hospital, the process completed by Dr. Faisal Al Mosawi. Mr. Jawad Al Arrayed initiated the decentralization of the ministry of health budget, but unfortunately, it was not implemented because he was transferred to another ministry. Dr. Faisal Al Mosawi (former minister of health, 1995-2002) sought and delivered the much-needed international recognition of medical and surgical training in SMC and BDF, which made it easier for our young doctors to finish their training at home and to go abroad only for the final touch up; he also laid the foundation for formal relationship with the Royal College of Surgeons in Ireland (RCSI), which paved the way to the establishment of the Royal College of Surgeons in Ireland-Medical University of Bahrain. Dr. Khalil Hassan, Dr. Nada Hafadh and Dr. Faisal Alhamar (former ministers of health, 2002-2011) have encouraged and expanded on the previous policies.

In the sixties, Bahrain had a cottage hospital staffed 99% by non-citizens. After four decades, Bahrain had the most sophisticated modern government hospitals and health centers, 90% staffed by qualified and trained Bahraini citizens. Besides that, Bahrain had several private hospitals owned by Bahraini citizens. In addition, two medical journals were established during this period, the first one is Bahrain Medical Bulletin, which was established in 1979 and it is the one promoting research in Bahrain and the region. During that period, several medical colleges were established, including the RCSI-MUB. The medical body in Bahrain became the glory and the envy of the GCC.

The medical dream would not have been achieved without the help and heavy investments, which have started during the era of Sheikh Sir Salman Bin Hamad Al Khalifa, followed by heavier investments and expansion during the era of Sheikh Isa Bin Salman Al Khalifa. His Majesty King Hamad followed his father policy of heavy investments in medical establishment and he expanded on it.

This year the medical body faced crisis from within and from without threatening its collapse. It is hoped that those who perpetrated the crisis from both sides will realize their mistakes and will work together to help the medical body recover. I have a great faith that his Majesty King Hamad's wisdom and far vision would prevail and restore the medical body to its previous glory and reinstate the celebrated stance of Bahrain in medicine.

I hope that both sides could overcome the vindictive passion of resentment, anger, hatred and the desire for revenge, submitting totally to these passions is often very dangerous. I hope and most Bahrainis hope that all parties involved to exercise self-control, allow the passions to dissipate and choose to forgive, move beyond bitterness and respond with compassion, benevolence and empathy, as we always do in our profession.

McCarthyism and demagogic attacks on the character is a dangerous practice and should never be encouraged or condoned in our profession, this could lead the professionals to suffer loss of employment and/or destruction of their careers; some even suffer imprisonment.

Let us remember that most of the punishments during McCarthyism came about through trial verdicts, which was overturned later; even the laws enacted then were declared unconstitutional and dismissals for reasons were declared illegal.

To my colleagues, let us work together to preserve the sanctity of our profession, help our juniors to develop self-confidence in their work skills, create a positive emotional environment at work and to develop strong personal values for performance goals.

Despite all the difficulties the medical profession faced, Bahrain Medical Bulletin had celebrated the fourth year of Dr. Mohammed Bin Abdullah Al Khalifa's Medical Research award, which was held on 28 October 2011 at RCSI-MUB. The celebration is a proof that Bahrain is on its way to establish itself as center for medical research and publication. The prize celebration was held under the auspices of HH Sheikh Mohamed Bin Mubarak Al Khalifa, the deputy prime minister. The prize aims to honor the winners who produced the best medical research, published in the Bahrain Medical Bulletin during 2010. Attended the celebration Sheikh Khalid Bin Abdulla Al Khalifa, the second deputy prime minister and RCSI president, Tom Collins and other recognized pioneers and leaders of the medical profession in the Kingdom of Bahrain and the region.

Dr. Mohammed Bin Abdullah Al Khalifa Prize for Medical Research and Dr. Ali Al Khalifa research fund (BD 10,000/\$27,000) were established to encourage medical and paramedical research and to improve the quality of medical practice in Bahrain and the Arab world. The Prize awarded by the Bahrain Medical Bulletin is considered one of the most important medical events held in the Kingdom of Bahrain. The ceremony aims to celebrate the researchers who have contributed highly in raising the level of health and medical services through their research.

Research award winners were selected by distinguished senior consultants including the elite of the specialists in the Kingdom of Bahrain and abroad.

Finally, our dedication should be solely to our profession, which dictates research and improvement. Now I would like you to take home a message, "encourage your colleagues to do research, only through that we can improve medicine and medical care and in turn serve our patients.
